





REPORT FROM THE INTERNATIONAL UNIT

THE VOLUNTEER SCHEME

One of the main volunteer scheme projects of 2014 was a visit by UK volunteers to Kashmir. Four volunteers - Dr Peter Hughes, Dr Sajad Yousuf, Dr Parimala Moodley and Dr Howard Ryland travelled from the UK to Kashmir to deliver 5 days of training to a number of health professionals using the mhGAP curriculum. The mhGAP (mental health gap action plan) is a WHO programme designed to scale up care for mental, neurological and substance use disorders among non-specialist providers, including primary healthcare worker

The project was coordinated by Dr Sayeed Ageel Hussain, a College Member based in Kashmir, and was facilitated by the Director of Health Services in Kashmir, Dr Saleem-Ul-Rehman.

Kashmir - the first volunteer project took place in September 2013. The visit in August 2014 was set in the Ganderbal district and the training was attended by over 35 doctors, nurses, pharmacists, social workers and students. The objectives of the training were to ensure that those present became familiar with the mhGAP programme, acquired the skills on assessment, diagnosis and management of priority conditions, mastered various models of training methodology and training techniques, facilitator skills and supervision skills. The volunteers were also looking to identify a pool of potential champions of mhGAP in Kashmir to develop a strategy for supervision.

This training event was successful and the course facilitators reported being impressed with

commitment, enthusiasm and interest of rticipants in applying mhGAP to their work. It oped that stakeholders in Kashmir will develop s programme of work by ensuring that capacity naintained through follow-up with participants

This project in Kashmir has also brought about the establishment of a Memorandum of Understanding between the College and the Health Services Department in Kashmir and Jammu which was signed by Professor Sir Simon Wessely and Dr Saleem-Ul-Rehman in August 2014.

This is for the information of Everyone including Collaborating partners, Trainers and Trainees of mhGAP Training conducted in 2013 in collaboration with Directorate of Health Services Kashmir, Royal College of Psychiatrists London, WHO Geneva and Logistic support by J and K police, Help foundation, Action Aid India, TCI cements and Jammu and kashmir Bank.

The programme was conducted over two weeks in which more than 200 professionals which included doctors, nurses, psychologists, social workers, teachers, police personals and allied professionals from all 12 districts of kashmir participated.

The report of the programme was formally submitted to Govt of Kashmir by Royal College of Psychiatrists London and has been used as reference in papers around the world.


The Directorate of Health services published the project as one of its achievement in its 2013 achievement report and the success of the project led to the signing of MOU next year between Kashmir Government and Royal College of Psychiatrists London which was signed by then Commissioner secretary Health and Medical Education Mr Gazanfar Hussain and Prof Sir Simon Wesley President of the Royal College of Psychiatrists London.

This was followed by another mhGAP training project in District Ganderbal under MOU in 2014 followed by monitoring and evaluation of the training. Unfortunately the Psychiatric institute refused to depute psychiatrist for the

Govt supported project on my request as a faculty member of the Institute for monitoring and evaluation but deputed entire team to project run by MSF and to 22500000 Rs funded private project of Professor Margoob who had retired from Government and had no other official support from the Government.

Also Professor Margoob refused to work in collaboration with Govt supported project which would have helped his project immensely as advised by Dr Hussain without giving any valid reason

The completion of the mhGAP kashmir project took two years and the results were presented by Dr Sayed Aqeel Hussain Consultant Psychiatrist and Initiator, coordinator and implementor of Programme on ground at the mhGAP forum of WHO assembly Geneva following which mhGAP kashmir project was nominated as the most popular innovation in the world out of more than 120 nominations.



BACK GROUND OF PROJECT.

Prof Margoob Ex HOD Psychiatry who retired in 2013 refused to entertain Dr Sayed Aqeel Hussains proposal as member of faculty of the institute to invite RCPsych to kashmir to impart training using WHO devised mhGAP training module.He however used the same training module to train trainees of his private project in 2014.

The proposal was presented to Dr Saleem ur Rehman then Director Health Services Kashmir who immediately approved the proposal and formal invitation was sent to the President of the RCPsych to depute trainers for training.



Unfortunately Prof Margoob not only did not support the project along with the Psychiatric Institute but made a statement in the paper published by the Canadian Journal of Psychiatry that the mhGAP project supported by Govt of Kashmir and RCPsych has failed without providing any evidence.







The district of Ganderbal in the Kashmir valley extends to the north from the outskirts of the city of Srinagar through the Kangan valley to very remote mountainous regions, including the Thajvas glaciers. The district has a population of 297,000, which is predominantly rural (84%), with a low literacy rate (58% compared with the national average of 74%).30 Within this district, our project aimed to cover an area with a population of 200,000. We selected Look Up this re Copy Share... or no access to governmental mental health services. A 2-week Mental Health Gap Action Programme (mhGAP) training initiative delivered by The Royal College of Psychiatrists (UK) in 201331 created little improvement in access to mental health services. The mental health needs were served—albeit to a very limited extent—by SAWAB ("Supporting Always Wholeheartedly All Broken-hearted," an expression in Kashmiri meaning an act of kindness without expecting anything in

This statement was defended by one student of Prof Margoob in UK against basic principles .

One Consultant Psychiatrist Dr Mudasir Firdosi who along with being the student of Prof Mushtaq margoob in Institute of Mental health and Neurosciences Kashmir during his postgraduation and has published several papers along with Professor Margoob who served as Head of Department of the Institute before retiring in 2013 took objection to the statement.

He Is also a member of Royal College of Psychiatrist London and is currently working as a Consultant Psychiatrist in London.

Dr Firdosi made a charged and emotionally strong statement for objecting to the statement made by Porfessor Margoob in the paper even before reading the statement . Dr Firdosi was advised to read the statement which he did and felt that there was nothing wrong in the statement and it was entirely my responsibility to prove the success of the project.


It was highlighted to Dr Firdosi that the burden of proof is usually on the person who brings a claim in a dispute and the necessity of proof always lies with the person who lays charge.

Thank you again for your patience and understanding as we worked to thoroughly understand the situation and provide the best course of action. We have expended extensive time in reviewing the statement and other information, as well as consultation with the authors and Journal Editor, and are now moving forward with publishing the following corrigendum, which we believe satisfactorily clarifies the article.

Corrigendum for A Model of Mental Health Care Involving Trained Lay Health Workers for Treatment of Major Mental Disorders Among Youth in a Conflict-Ridden, Low-Middle Income Environment: Part I Adaptation and Implementation

The authors have provided additional clarification for their comments on the *Mental Health Gap Action Program*, described in the 'Site Description' section of the article, appearing on page 623, as having "provided little improvement to access to health services" at the time they began their project in 2013:

According to the Mental Health Innovation Network website

at https://www.mhinnovation.
net/organisations/implementation-mhgap-kashmir, the program's initial two-week preliminary primary care training was conducted in September 2013, and additional training phases of the mhGAP program were apparently conducted subsequently.

The authors' comments that the mhGAP program had produced little benefit to access to mental health care at the time of commencing their program in 2013-2014 reflects the contemporaneous observation of their local team of clinician investigators. No peer reviewed evaluation of the mhGAP program was available and the original statement in the article should have clarified that it was based on the clinician investigators' observations at the time when the initial mhGAP training initiative had only recently been delivered.

We appreciate your bringing this matter to our attention and hope you agree this satisfactorily resolves the matter. Please let me know if you have any questions or concerns. We expect the corrigendum will be online within the next two weeks.

The Editors of the journal were thanked for impartial investigation and publication of the Corrigendum.

The team members or their Institutes refused to reply to request by Dr Sayed Aqeel Hussain to provide evidence or issue corrigendum like Grand Challenges Canada which funded Professor Margoobs Rs 22500000 private project.

Instead of replying Prof Margoob and Dr Abdul Majid currently HOD Psychiatry SKIMS Medical College wrote an email to Royal College of Psychiatrists that Dr Sayed Aqeel Hussain was planning to file legal petition against the Journal and Authors which was contradictory to facts as Corrigendum was already issued.

Dear Professor Margoob

Further to me email below I can confirm that while Dr Aqeel Hussain is a Fellow of the Royal College of Psychiatrists, he holds no office within the College and does not act or speak on behalf of the Royal College of Psychiatrists. Dr Hussain is acting in an personal capacity.

I can also confirm that the Royal College of Psychiatrists has not lodged a complaint with the Canadian Journal of Psychiatry and the Royal College of Psychiatrists has not begun any legal proceedings against the journal or the authors of the referenced article, and it has no intention of doing so.

The College replied to the Authors and Prof margoob shared the reply which contained content contradictory to facts on ground in social media.

Also the Language in the reply mail did not seem to reflect the original mail received from the RCPsych.

The College was informed of the email circulation and Prof Uzri Head of International Division of the RCPsych again confirmed that he had recommended Dr Sayed Aqeel Hussain to write to Editors of the Journal to investigate the matter and following the investigation a Corrigendum was published which made it clear that the email circulated in social media by Prof margoob that Dr Sayed Aqeel Hussain was planning to file legal petition against the Journal and its authors was contradictory to the facts on ground and the only aim of Prof Margoob and Dr Majid was to destroy Dr Sayed Aqeel Hussain's credibility and work done on ground in order to cover the outcome of investigation by Canadian Journal of Psychiatry.

This also supported the fact that aim of the false statement published by Prof Margoob was only to destroy Dr Sayed Aqeel Hussain's credibility and work done in collaboration with reputed organisations like RCPsych.

To promote this paper with false statement against work done in kashmir Prof Margoob asked one of the Consultant Dr Sheikh Shoib to promote this paper as reference. Dr Shoib works as Consultant Psychiatrist in Directorate of Health services kashmir which was one of the main Collaborating partner of the project and it was on invitation of Director Health services kashmir that the team of RCPsych came to kashmir.

It was highlighted to Dr Shoib that the paper he was promoting was sharing a statement against the work of his own department without evidence and it also shared contradictory figures about the psychiatric manpower of Directorate of Health services kashmir which were refuted by Consultant of IMHANS in one of the webinar.

Despite evidence he continued to promote the 22500000 Rs project of Prof Margoob for his own vested interests and discredit the work of his own parent department.

Professor Margoob and the team of his project working in IMHANS, SKIMS, Medical college Baramulla and Dr Shoib from Directorate of Health services kashmir are warned to be careful in future and advised to follow ethical guidelines in making any statement regarding Dr Sayed Aqeel Hussain's work in kashmir done in collaboration with various national or international organisations in past or in future.

Dr Sayed Aqeel Hussain has successfully completed more than 10 projects in kashmir in collaboration with various National and International Organisations over last one decade with establishment of two crisis helpline in Jammu and Kashmir in collaboration with SDRF.,unfortunately the work done in Kashmir in collaboration with various organisations especially RCPsych has been repeatedly undermined by various faculty members of IMHANS through press and social media and publication of false statement in Canadian Journal of Psychiatry against the work done in collaboration with RCPsych being a prime example.










Two week mhGAP training in Kashmir extremely successful

Following the excellent response to the <u>advertisement</u> for volunteers, 10 master trainers in the WHO mhGAP intervention guide, and members of international and voluntary special interest group of the Royal College of Psychiatry, successfully completed a two week mhGAP training in Kashmir. The trainers of the programme included consultants of various specialities including general adult, old age, psychotherapy, neuropsychiatry, learning disabilities, child and adolescent psychiatry as well as psychiatric trainees from various reputable institutions.

The training programme had the following aims:

- · Train the relevant work force in assessment, treatment and appropriate referral to secondary services based on the WHO Mental Health Gap Intervention Guide in order help reduce the mental health gap, especially in primary care settings;
- · Set-up an infrastructure to monitor the implementation of relevant guidelines and to monitor the response to intervention and
- · Strengthen interagency liason for effective delivery of services using bio psycho social approach

More than 100 trainees both

from Kashmir and other states of India were trained, including general physicians, nurses, teachers, NGOs, psychologists, lawyers, social workers, police personnel and people from various other disciplines.

Representatives of PRIME and Prof Vikram Patel also attended the training session.

The following individuals received awards of appreciation for their role on the programme, and their outstanding contribution and commitment towards reducing the mental health gap in Kashmir:

Dr Sayed Aqeel Hussain, consultant psychiatrist and member of Royal College of Psychiatry, for initiating the project and coordinating it at the international level;

Dr Muzaffar Khan, Director of Police Addiction services in Kashmir, for successfully coordinating the project at state level.

Mrs Nighat Shafi, for her outstanding contribution to the cause of women and children especially in the field of mental health.

Mr SM Sahai, ADGP, for initiating drug addiction services on behalf of police in Kashmir.

This is the first successful mhGAP training programme in whole of India and will serve as a role model for mhGAP training in rest of India in the future.

The Response by Professor Margoob and his team raises several unanswered questions.

- 1. Why did Professor Margoob refuse to reply to Query by Dr Hussain to produce evidence to substantiate the claim that the 2 week training conducted in collaboration with RCPsych failed to produce results forcing the principle author Prof Ashok Malla to advise Dr Hussain to write to editor of the journal to initiate investigation.
- How did Prof Margoob and his team come to conclusion by just relying on District Ganderbal when the training was conducted in 12 districts of kashmir.
- 3. How did Prof Margoob and his team come to conclusion when the main training project followed by intensive monitoring and evaluation started after

the start of Professor Margoob and his teams project.

- 4. How did Prof Margoob and his team come to conclusion when they had no access to the cases seen by permanent members of Govt Supported team in primary care centres as the cases seen by his team were cases of patients seen in community.
- 5. Why did Prof margoob and his team not mention that the main training monitoring and evaluation project implemented as part of MOU between Govt of Kashmir and RCPsych under the supervision of Dr Sayed Aqeel Hussain who was working as Consultant Psychiatrist in Govt Psychiatric disease hospital started after the two week training as highlighted in the Corrigendum published by Canadian Journal of Psychiatry following investigation.

- 6. Why did Prof Margoob and his team not mention that this statement was based on observation rather any documented evidence or data as highlighted in the Corrigendum published by the Canadian journal of Psychiatry.
- 7. Why did Prof Margoob refuse the request to work in collaboration with Govt supported project in 2014 as both projects were running in District Ganderbal.
- 8. Why did Govt psychiatric disease hospital refuse to provide any support to Govt supported project to depute team for monitoring and evaluation as requested by Dr Sayed Aqeel Hussain who was working as a faculty member at the institute but deputed team to 22500000 Rs private project of a retired psychiatry professor.

- 9. Why did Professor Margoob team refuse to reply to Dr Sayed Aqeel Hussain request whether they made observation and recommendation to Prof margoob to publish statement that the two week training conducted in collaboration with RCpsych and WHO failed to produce any results.
- 10. Why does Prof Margoobs team refuse to explain how they came to conclusion and made this observation.
- 11. Why did Prof Margoob write to RCPsych that Dr Sayed Aqeel Hussain was planning to initiate legal proceedings against the journal without RCPsych permission when the investigation initiated by the journal on the recommendation of Prof Mohammad Uzri head of International Division of the

RCpsych had already been completed and corrigendum issued.

- 12. Are Prof Margoobs and his team not responsible for damaging the credibility of Dr Sayed Aqeel Hussain and his work by blaming him for planning to initiate legal proceedings against the Journal on behalf of RCPsych without their permission.
- 13. Why did Prof Margoob and his team circulate in entire social media so called email by RCPsych that Dr Sayed Aqeel Hussain was planning to initiate legal proceedings against the Canadian Journal of Psychiatry on behalf of RCPsych without seeking RCPsych permission.
- 14. Are Prof Margoobs and his team not liable to defamatory charges by Dr Sayed Aqeel Hussain for trying to damage the reputation and credibility of Dr Sayed Aqeel Hussains work done in kashmir in

collaboration with various National and International organisations including RCPsych by circulating false information on social media.

- 15. Why Did Dr Shoib who is working as a Consultant Psychiatrist in Directorate of Health services kashmir one of the main Collaborating partner in mhGAP training in kashmir refuse to write to editors of the journal to remove reference of Prof margoob project that discredited the work done by Directorate of Health services in collaboration with RCPsych and WHO without evidence.
- 16. Why did Dr Shoib actively promote the paper when it mentioned figures regarding the psychiatric manpower of Directorate of Health services kashmir which was contradictory to figures on

ground and which were even disputed by Consultant psychiatrist of IMHANS in a recent webinar conducted in collaboration with BKMA.

- 17. why did Prof Margoob advocate the use of mhGAP training of Pakistan in kashmir while completely dismissing the mhGAP project completed in kashmir by Govt of kashmir in collaboration with various National and International organisations like RCPsych and WHO.
- 18. It is unfortunate that Dr Mudasir Firdosi working as Consultant Psychiatrist in UK and principle investigator in a research project in uk and has been student of Prof Margoob tried to justify the statement of Prof Margoob in the paper and putting responsibility on Dr Hussain to disprove the statement forgetting the principle that the burden of proof is usually on the person who brings

a claim in a dispute and the necessity of proof always lies with the person who lays charge

It is recommended that investigation be initiated and answers be sought from Prof Margoob and his team and recommendations be made by Govt that the Govt employees should provide complete support to Govt supported projects rather using Govt manpower and resources to support private projects for their own vested interests.

Dr Sayed Aqeel Hussain is currently seeking legal opinion for filing defamatory suit against Prof Margoob and his team for deliberatory trying to damage the reputation and credibility of Dr Sayed Aqeel Hussains work on social media.

Dr Sayed Aqeel Hussain will also not be responsible for any legal proceedings initiated by RCPsych or its team members for trying to

distort the content of the correspondence email if any by Professor Margoob and its team.

Finally this statement and action by Professor Margoob and its team has seriously damaged the credibility of the Govt of Kashmir especially by members of Govt Psychiatric Institute Srinagar, Psychiatric institute SKIMS medical college and Dr Sheikh shoib consultant Psychiatrist working in Directorate of Health services kashmir which was one of the main collaborating partner of the mhGAP Project in kashmir.

This will prevent International organisations working on world stage to stop collaborating with Govt of Kashmir in any future projects.

I hope the Govt will fully investigate the matter and take necessary action in order to deter professionals and Govt employees from discrediting the work of Govt and damage

reputation on world stage for their own vested interest.
